## 1. APPLICATION OF THIS AGREEMENT

If the Participant is 18 or 19 years of age, the Participant must sign this Agreement.

If the Participant is under 18 years of age (13–17), a Parent or Legal Guardian must sign on the Participant's behalf.

“Organization” means Rated Sports Group, the Phoenix Cup, and their respective directors, officers, employees, coaches, referees, volunteers, contractors, sponsors, facility owners/operators, agents, representatives, and affiliates.

“Activities” include soccer games, ID camp sessions, training, drills, scrimmages, strength and conditioning, use of equipment and facilities, travel to and from the event, and all related activities.

## 2. ASSUMPTION OF RISKS

Participation in competitive soccer and ID camp activities involves risks including, but not limited to:

- Collisions with players, referees, spectators, or objects
- Contact with soccer balls, goals, nets, posts, fencing, or equipment
- Falls on grass, turf, or uneven surfaces
- Concussions, head injuries, spinal injuries, fractures, sprains, strains

- Overexertion, dehydration, heat-related illness
- Equipment failure or malfunction
- Exposure to communicable diseases
- Negligence of other participants or the Organization

These risks may result in serious bodily injury, permanent disability, paralysis, or death. The participant knowingly and voluntarily assumes all such risks.

### **3. MEDICAL FITNESS & CONSENT**

The Participant is physically and mentally fit to participate and has disclosed any medical conditions.

In the event of injury or medical emergency, the Organization may obtain emergency medical treatment. The signer agrees to be financially responsible for any medical care provided.

### **4. RELEASE OF LIABILITY**

The signer waives all claims against the Organization and releases it from liability for injury, illness, death, property damage, or loss arising out of participation in the Activities, including claims arising from negligence to the fullest extent permitted by Arizona law.

### **5. INDEMNIFICATION**

The signer agrees to indemnify and hold harmless the Organization from any claims, damages, losses, liabilities, or legal expenses arising out of the Participant's actions or conduct.

### **6. FACILITY & PROPERTY**

The Organization is not responsible for loss, theft, or damage to personal property, equipment, or vehicles.

### **7. COMMUNICABLE DISEASE ACKNOWLEDGMENT**

Participation may involve exposure to communicable illnesses. The signer voluntarily assumes all risks related to such exposure.

### **8. RULES & CONDUCT**

The Participant agrees to follow all rules, act safely, use appropriate protective equipment, and remove themselves if unsafe conditions arise. Failure to comply may result in removal without refund.

### **9. GOVERNING LAW**

This Agreement is governed by the laws of the State of Arizona. Any legal action must be filed exclusively in Arizona. If any provision is invalid, the remainder shall remain in effect.

## 10. ACKNOWLEDGMENT

The signer acknowledges that they have read and understood this Agreement, understand they are giving up substantial legal rights, and sign voluntarily.
